The regular meeting of the Wellsville City Council was held on Wednesday, February 11th 2015 at 6:00 p.m. in the Wellsville City Hall meeting room, located at 411 Main Street. Councilmen present were Jared Eggleston, Dave Rogers, Chuck Rutledge and Cory Cunningham. Department heads present were City Superintendent Christopher Cross, Building Inspector Wes Brown, Police Chief John Blair and City Attorney Patrick Reavey.

Councilman Ryan Eiche was absent.

Councilman Cory Cunningham moved to approve the consent agenda. Councilman Chuck Rutledge seconded. Motion passed 4-0

Mayor Lytle opened the meeting for public comments.

There were no public comments.

Commissioner Randall Renoud gave the county activity report.

Mike Mustain with Central Fiber extended a huge thank you to all departments who assisted with controlling the Fire.

Wynndee Lee with the Active Transportation committee presented a layout of County and Wellsville specific bicycle & pedestrian plans in the rural areas of Franklin County. The goal is to create a plan to direct the cities and the County so people can choose to use the paths for transportation or for exercise. Installation of signage, paths and plans will be available for users.

Council spoke regarding a construction proposal for the city park. Christopher Cross said there was a sidewalk along the east side that was taken out when the construction of the pool took place. He would like to replace that sidewalk and widen it for wheelchair accessibility. A bid from Rick Saylor was presented to council in the amount of \$4200.00.

Consensus of the council was to get other bids and to make all of the sidewalks the same width.

The Wellsville Police Department was in attendance at the meeting to introduce a payroll proposal to change payroll dates. Council spoke on this matter and decided to look at this matter at a later date.

Councilman Chuck Rutledge voted to table the matter for further discussion.
Councilman Dave Rogers seconded.

City Superintendent Christopher Cross gave the utility department activity report. Supt. Cross stated the pool is in good shape but the interior finish needs fixing. The Fire and Ambulance generator is in working condition. The yearly water use report for 2014 was 49 million that was purchased at a 5.2 % loss.

Police Chief John Blair gave the activity report for the Police Department. Chief Blair stated they received 3 new lockout tools. Officer Ward received a thank you on a medical call. Teen seat belt enforcement is Feb. 23 thru March 6th.

Councilman Jared Eggleston moved to go into executive session for 30 minutes to discuss personnel. City Attorney Patrick Reavey was asked to stay. Councilman Dave Rogers seconded. Motion passed 4-0.

Council went into executive session at 6:55.

Councilman Jared Eggleston moved to come out of executive session. Councilman Cory Cunningham seconded. Motion passed 4-0.

Council came out of executive session at 7:25. Only the above item was mentioned and no motions were made.

Councilman Chuck Rutledge moved to adjourn. Councilman Jared Eggleston seconded. Motion passed 4-0.

Meeting adjourned at 7:30 p.m.
