The regular meeting of the Wellsville City Council was held on Wednesday, October 14th 2015 at 6:00 p.m. in the Wellsville City Hall meeting room, located at 411 Main Street. Councilmen present were Dave Rogers, Jared Eggleston and Chuck Rutledge and Ryan Eiche. Department heads present were Police Chief John Blair, City Superintendent Christopher Cross and City Engineer Mike Brungardt.

Absent was Councilman Cory Cunningham.

The pledge of allegiance and invocation were given.

Councilman Dave Rogers moved to approve the consent agenda. Councilman Chuck Rutledge seconded. Motion passed 4-0.

Mayor Lytle opened the meeting up for public comments. There were no public comments.

Chief Blair presented Eagle Scout Adam Creviston and Mr. Don Caruthers with a certificate of appreciation. Adam sanded the deck of the Police Department. He also painted and refurbished the sign and put a roof on the dog kennel. Mr. Caruthers made the letters for the Police Department sign free of charge.

Meg Pearson of the United Way of Franklin County gave a presentation to the council. She spoke about corporate partners and volunteers who work together to promote healthy lifestyles, improve local education, and help people achieve financial stability. She also asked if the employees would like to make payroll deductions. The Council agreed to hand out the information to the employees.

City Commissioner Randal Renoud gave the county activity report.

City Engineer Mike Brungardt spoke regarding ADA Accessibility to downtown. He discussed that SE corner of 5th and Main and the NE Corner of 6th & Main would serve the East half of Main Street very well at very little cost.

Councilman Dave Rogers moved to approve the painting and signage for handicap parking at the SE Corner of 5th & Main and the NE Corner of 6th & Main. Councilman Jared Eggleston seconded. Motion passed 4-0.

Councilman Dave Rogers moved to table the utility rate study. Councilman Jared Eggleston seconded. Motion passed 4-0.

Councilman Jared Eggleston moved to table the moving of the November 11th meeting. Councilman Chuck Rutledge seconded. Motion passed 4-0.

City Superintendent Christopher Cross gave the Public Works activity report. He stated that the street work is done.

Police Chief John Blair gave the Police Department activity report.

Councilman Ryan Eiche moved to go into executive session for 10 minutes to discuss personnel. Councilman Jared Eggleston seconded. Motion passed 4-0. Council went into executive session at 6:50 p.m. City Clerk Tammy Jones was asked to stay.

Councilman Jared Eggleston moved to come out of executive session. Councilman Dave Rogers seconded. Motion passed 4-0.

Council came out of executive session at 7:00 p.m. no motions were made and only the above mentioned item was discussed.

Councilman Jared Eggleston moved to adjourn. Councilman Chuck Rutledge seconded. Motion passed 4-0.
