The regular meeting of the Wellsville City Council was held on Wednesday, January 9th, 2013 at 6:00 pm in the Wellsville City Hall meeting room, 411 Main Street. Councilmen present were Ryan Young, David Rogers, Jared Eggleston, Mike McAfee and Cory Cunningham. Department heads present were Chief of Police Steve Gillespie and City Superintendent Chris Cross.

Mayor Lytle called the meeting to order at 6:00 p.m.

The pledge of allegiance and invocation were given.

Councilman David Rogers moved to approve the consent agenda as submitted. Councilman Ryan Young seconded. Motion passed 5-0.

Mayor Lytle opened the meeting up for public comments that had not been previously placed on the agenda.

There were no additional comments from the public.

Councilman David Rogers moved to block of a portion of city sidewalk for the Chicks and Chaps. Councilman Mike McAfee seconded. Motion passed 5-0.

Councilman Mike McAfee move to approve Gregg Neis CPA contract audit of 2012 city financial statements. Councilman David Rogers seconded. Motion passed 5-0.

There was discussion regarding the Police Department ceiling and the bids that were received from Jason Bell and R. Martin

Councilman David Rogers moved to approve the bid from J. Bell for the sheet rock ceiling for the Police Department along with the flush mounted lighting system not to exceed the amount of \$6903.02. Councilman Mike McAfee seconded. Motion passed 5-0.

City Superintendent gave a public works report. Superintendent Cross asked councils permission to sale the 1992 work truck and try to get \$500.00 out of it.

Councilman Mike McAfee moved to take bids on the truck with a minimum of \$500.00. Councilman Dave Rogers seconded. Motion passed 5-0.

Chief Gillespie gave the Police Department activity report. Chief stated he went to the County's Emergency Management meeting today along with Councilman Mike McAfee and Superintendent Chris Cross. Superintendent Cross stated that the City needs to find an area for debris in case of a tornado or an ice storm. Chief Gillespie also spoke regarding the speed limit signs on Vermont. The consensus of the council was to let Chief Gillespie write a letter telling the county the City of Wellsville will let the County make the decision on the speed limit sign. Chief Gillespie gave the council a memo regarding the current WPD vehicles. Council requested bids on a new police car.

Mayor Lytle stated that City Attorney Patrick Reavey will be at the January 30th meeting with a timeline regarding the Fire District.

Mayor Lytle also pointed out that there are 3 Council seats open that will expire in April 2013.

Mayor Lytle also talked regarding the Ottawa Herald who is currently taking nominations for their annual progress addition. The addition consists of three individual week's addition.

Councilman Mike McAfee move to adjourn the meeting. Councilman Ryan Young seconded. Motion passed 5-0.

The meeting adjourned at 7:10 p.m.
