Councilman Jared Eggleston moved to approve Christmas bonuses at \$750.00 for full time and \$375.00 for part time employees. Councilman Dave Rogers seconded. Motion passed 4-0.

Councilman Jared moved to close City Hall on Christmas Eve. Councilman Dave Rogers seconded. Motion passed 4-0.

Councilman Chuck Rutledge moved to change the meeting on December 31stto December 30th at 5:30 with no agenda. Councilman Dave Rogers seconded. Motion passed 4-0.

City Superintendent Christopher Cross gave the public works activity report. He asked that council give him time for a study session to discuss a building.

Councilman Jared Eggleston moved to approve at 30 minute study session on December 10th at 5:30 p.m. Councilman Dave Rogers seconded. Motion passed 4-0.

Police Chief John Blair gave the police department activity report. The Police Chief said he attended a meeting with Franklin County they will possibly be going with a digital radio system.

Councilman Dave Rogers moved to allow the on duty or on call public works to take a vehicle home. Councilman Chuck Rutledge seconded. Motion passed 4-0.

Councilman Chuck Rutledge moved to approve the Officer that lives in town take a Police vehicle home. Councilman Dave Rogers seconded. Motion passed 4-0.

The consensus of the council was to allow Wes Brown to put a magnetic sign on the Impala that says Code Enforcement City of Wellsville.
