The regular meeting of the Wellsville City Council was held on Wednesday, February 13, 2013 at 6:00 p.m. in the Wellsville City Hall meeting room, 411 Main Street. Councilmen present were Ryan Young, Jared Eggleston, David Rogers and Mike McAfee. Councilman Cory Cunningham was absent. Department heads present were City Supt. Christopher Cross and Fire Chief Robert Thomas.

Mayor Lytle called the meeting to order at 6:00 p.m.

Councilman David Rogers moved to approve the consent agenda. Councilman Mike McAfee seconded. Motion passed 4-0.

Mayor Lytle opened the meeting up for public comments on items that had not been previously placed on the agenda.

There were no comments from the public.

Franklin County Commissioner Don Stottlemire spoke about the drought situation. He talked about the Senate bills and the House bills that may affect our city in the future.

Mayor Lytle appointed Jared Eggleston to the Fire District board with the appointment ending the end of 2013. Councilman Ryan Young moved to appoint Councilman Eggleston. Councilman David Rogers seconded.

Councilman Mike McAfee voiced some concerns.

Motion passed. Councilman Ryan Young and Councilman David Rogers voted yes. Councilman Mike McAfee voted no. Councilman Jared Eggleston Recused. Motion passed 2-1.

Fire Chief Robert Thomas gave the Fire Department report. He stated he needed a new door lock for the station at a cost \$ 526.50.

Councilman Dave Rogers moved to approve the purchase of a lock not to exceed \$500.00.

Councilman Mike McAfee seconded. Motion passed 4-0

Robert Thomas asked for approval of the purchase of extrication equipment costing \$ 7567.50.

Councilman Mike McAfee moved to approve the purchase of extrication equipment at a cost of \$7567.50. Councilman David Rogers seconded. Motion passed 4-0.

Fire Chief Robert Thomas had an Inventory list that he turned in for review.

Mayor Lytle stated that the Council will review the Inventory and talk about it at the next meeting.

Mayor Lytle relayed to council that Officer Brandon Early backed into a vehicle with damages of \$700.00., which will be turned into the insurance company.

Councilman Mike McAfee had concerns about why the Police Department isn't getting their vehicles fixed when the need arises.

City Superintendent Christopher Cross gave the Public works activity report. Superintendent Cross stated that he spoke to BNSF about the quiet zone information and may have more to report at the next meeting.

Mayor Lytle spoke regarding the letter from Rural Water District No. 4 from Douglas County applauding Mr. Brungardts efforts in alerting the administrators to a class action suite which secured them an amount of \$55,278.49.

Councilman Mike McAfee moved to adjourn. Councilman Jared Eggleston seconded. Motion passed. 4-0.

The meeting adjourned at 6:38 p.m.
