The regular meeting of the Wellsville City Council was held on Wednesday, April 26th 2017 at 6:00 p.m. in the Wellsville City Council meeting room, located at 411 Main Street. Councilmen present were Tony Stanton, Kiel Lasswell and Cory Cunningham. Department heads present were City Superintendent Christopher Cross, Police Chief John Blair and City Engineer Mike Brungardt.

Councilman Chuck Rutledge and David Rogers were absent.

Mayor Lytle called the meeting to order.

Councilman Cory Cunningham moved to approve the consent agenda. Councilman Tony Stanton seconded. Motion passed 3-0.

Mayor Lytle opened the meeting up for public comments. There were no comments.

The special events permit for Chili Jacks was put before the council. Mike Chilton requested a permit for May 13^{th for} the WHS Alumni. He also requested one for June 17th for the Wellsville Friends foundation.

Councilman Kiel Lasswell moved to approve the WHS Alumni special event permit and the Wellsville Friends foundation s special events permit. Councilman Cory Cunningham seconded. Motion passed 3-0.

City Superintendent Cross spoke about some problems with damaged MTU's. The cost is approximately \$150.00 per unit to replace them if residents accidentally run over them with mowers etc. Superintendent Cross asked Council what they would like him to do regarding the replacement of the unit and who will pay for them. The question presented to council was, do we replace the MTU's or charge the homeowner the cost of the replacement. The council discussed what other towns do and if they have the same problems. Mr. Cross will check with other cities and report back to council.

City Engineer Mike Brungardt gave council a CIP briefing and overview of future and present projects that the Council was interested in doing within the City. Mike talked about the projects and their cost.

Chuck Breuer from Westland Construction spoke to the council about the 8th street waterline project and the design build. He thought that the process didn't work well for smaller contractors.

Mayor Lytle stated that this is the first design build the City has gone through and he understands that small companies may not have the staff that larger companies have.

Councilman Kiel Lasswell moved to table the 8th street water main project until the other councilmen are able to attend the meeting for further discussion since they were on the water main project committee. Councilman Tony Stanton seconded. Motion passed 3-0.

City Superintendent Christopher Cross gave the public works activity report. The water meters are at over 800 installed to date. The focus has been the pool, mowing and streets.

Police Chief John Blair gave the police department activity report. Ash street is 20 Northbound and South bound is 25. Chief wanted to get the sign changed to be the same across the board.

Councilman Cory Cunningham moved to adjourn the meeting. Councilman Kiel Lasswell seconded. Motion passed 3-0.
