The regular meeting of the Wellsville City Council was held on Wednesday, September 12, 2012 at 6:00 p.m. in the City Hall meeting room, 411 Main Street. Councilmen present were Cory Cunningham, Jared Eggleston, Ryan Youn, Mike McAfee and Dave Rogers.

The pledge of allegiance and invocation were given.

Mayor Lytle called the meeting to order at 6:00 p.m.

Councilman Dave Rogers moved to approve the consent agenda as submitted. Councilman Mike McAfee seconded. Motion passed. 5-0

Mayor Lytle opened the hearing up for public comments.

There were no comments.

County Commissioner Don Stottlemire gave the county activity report. Councilman Stottlemire stated that they took the burn ban off. He said they are putting together a new county website as well. The commissioners voted to give \$200.00 to the Wellsville American Legion.

Councilman Jared Eggleston moved to adopt Ordinance 844 the Standard Traffic Ordinance. Councilman Ryan Young seconded. Motion passed 5-0

Councilman Mike McAfee moved to adopt ordinance 845 the Uniform Public Offense code. Councilman Dave Rogers seconded. Motion passed 5-0

Councilman Dave Rogers moved to adopt ordinance 846 an ordinance imposing a special one percent city wide sales tax and related matters. Councilman Jared Eggleston seconded. Motion passed 5-0

City Engineer Mike Brungardt spoke regarding the structure at 418 Main and whether the structure is unsafe and dangerous and should reject the engineers report and what information should include in the engineers report.

Councilman Mike McAfee moved to adopt Resolution 01-912-2012. Councilman Dave Rogers seconded. Motion passed. 5-0

Councilman Mike McAfee moved to approve the special events permit for Hurricane Sherry's for Wellsville Days Saturday September 22nd. Councilman Cory Cunningham seconded. Motion passed 5-0.

Chief Gillespie gave the Police department report. Chief Gillespie introduced Brandon Early as the new Police Officer for the Wellsville Police Department.

Fire Chief Robert Thomas gave the fire department activity report. Chief Thomas asked council for \$500.00 for 10 text books for the Fire 1 class. Chief Thomas stated that there could be some reimbursement from the other entities.

Councilman Jared Eggleston moved to approve the purchase of 10 text books for a total of \$500.00. Councilman Ryan Young seconded. Motion passed 5-0

Councilman Dave Rogers moved to go into executive for 10 minutes to discuss personnel and asked Chief Gillespie to stay. Councilman Mike McAfee seconded. Motion passed 5-0

Council went into executive session at 6:28.

Councilman Mike McAfee move to come out of executive session, only the item mentioned above was discussed and no motions were made. Councilman Cory Cunningham seconded. Motion passed. 5-0

The meeting came out of executive session at 6:38

Mayor Lytle spoke regarding the petition and the water rates and looking into a level payment plan.

Councilman Mike McAfee moved to adjourn the meeting. Councilman Cory Cunningham seconded. Motion passed 5-0.
