Resolution 01-0509-2018 a Resolution to issue certain taxable industrial revenue bonds in an aggregate principal amount of not to exceed two million dollars for the purpose of purchasing, acquiring, construction, furnishing, and equipping a manufacturing facility located in the city was brought before the council.
