The regular meeting of the Wellsville City Council was held on Wednesday, June 27<sup>th</sup> 2018 at 6:00 p.m. in the Wellsville City Council meeting room, located at 411 Main Street. Councilmen present were David Rogers, Chuck Rutledge and Cory Cunningham. Department heads present were Police Chief John Blair, City Superintendent Darien Kerr and Planning Official Jerry Mallory.

Councilman Kiel Lasswell and Councilman Tony Stanton were absent.

The pledge of allegiance and invocation was given

Councilman Chuck Rutledge moved to approve the consent agenda. Councilman Dave Rogers seconded. Motion passed 3-0.

County Commissioner Randy Renoud gave the County activity report. Randy reported that the holiday schedule was approved for the year. They purchased a 60 inch mower. June 30<sup>th</sup> Rantoul has a fireworks display for the Community.

Leland Green with L & L Backhoe talked to council regarding a sewer at the property at 3<sup>rd</sup> and Main. The new home owner had a camera sent down the line and they saw issues at the Main. There was no leakage. They were going to backfill it with gravel because there was no problem. The new homeowner stated they didn't want it filled in they wanted it fixed. When he cut it loose at the house it busted. Our City Superintendent stated he wouldn't fix it because there wasn't a problem. Leland just wanted to be on the same page as to procedure and protocol for future reference.

Mayor Lytle stated that clear policy will need to be established from here forward and will be given to Leland for future reference.

Ordinance 892 amending the City Code to correct provisions pertaining to the sale (which is not allowed) and discharge of fireworks within the City of Wellsville.

Councilman Cory Cunningham moved to approve Ordinance 892. There was no second. Motion died for lack of second.

Councilman Dave Rogers moved to approve the special use permit for the Historical Society fundraiser event on July 14<sup>th</sup> from 6-10:00 p.m. Councilman Chuck Rutledge seconded. Motion passed 3-0.

City Superintendent Darien Kerr gave the public works activity report. Darien stated that the mower motor blew up today and he has gotten quotes on a new mower. Council would like to look at the warranty on the old mower before the new council meeting.

Officer Rachelle Foltz gave the Police Department activity report.

Building Official Jerry Mallory stated that North Star Housing will be starting to pull permits for the first 18 homes that will be built.

Councilman Chuck Rutledge moved to adjourn the meeting. Councilman Cory Cunningham seconded. Motion passed 3-0.
