The special budget public hearing and the regular meeting of the Wellsville City Council was held on Wednesday, August 8th 2018 at 6:00 p.m. in the Wellsville City Council meeting room located at 411 Main Street. The pledge of allegiance and invocation were given.

The Mayor called the 2019 budget-public hearing to order.

Mayor Lytle opened the hearing up for public comments.

There were no public comments.

Mayor Lytle closed the public hearing.

Councilman Chuck Rutledge moved to approve the consent agenda. Councilman Tony Stanton seconded. Motion passed 3-0.

Mayor Lytle opened the regular meeting up to the public

Jerry Webb spoke to council regarding a sewer cleanout she had done and she thought that part of the problem was on the city side. Mrs. Webb produced a bill and documentation from A & H. The City was never contacted that Ms. Webb had a sewer issue to begin with.

Councilman Chuck Rutledge stated we need to do some research on the issue.

Leland Green requested to know what kind of policy we have set up regarding sewer line repairs and who is responsible for those repairs.

Council stated they would have a study session on August 13th at 6:00 p.m. at the City Hall. Mr. Green and any contractors interested are welcome to attend to have some input for a policy.

Dave Wagner spoke to council regarding the sewer line problem and questions he is having on the new property he is building on Pendleton Court. Building and Planning Official Jerry Mallory answered Mr. Wagners questions. He asked if he could work with the Superintendent on some sewer caps in the future.

Councilman Chuck Rutledge moved to approve the 2019 budget. Councilman Tony Stanton seconded. Motion passed 3-0l.

City Superintendent Darien Kerr gave the public works activity report. Darien stated that the storm siren has been put up.

Police Chief John Blair gave the police department activity report. Chief stated he has had a meeting with the Superintendent from the School regarding the SRO.

Councilman Kiel Lasswell entered the meeting at 6:27 p.m.

Chief Blair also stated that he sent in a list of light poles in the City that would need to be repaired to KCP & L.

Officer Foltz wants to take an EMT course and the cost is \$800.00. The class starts August 20th.

Councilman Dave Rogers moved to offer training to officer Foltz. Councilman Chuck Rutledge seconded. Motion passed 4-0.

Officer Hackler is working on a Firehouse sub grant to provide a new vehicle in the amount of \$27,864 to the Police Department the grant is for the vehicle only and does not cover and of the equipment. Officer Hackler asked council if he could proceed with the grant process

The consensus of the council was for Officer Hackler to proceed with the grant application.

Building Official Jerry Mallory gave the activity report on the cul óde- sac and the housing project on West 4th.

Councilman Chuck Rutledge moved to adjourn the meeting. Councilman Tony Stanton seconded. Motion passed 4-0.
