Ordinance No. _905___ Summary

On March 13, 2019, the City of Wellsville, Kansas, adopted Ordinance No. _905____ (to be effective on April 1, 2019) amending the City Code to make it consistent with Kansas State law which, on and after April 1, 2019, will allow licensed retailers to sell 6% cereal malt beverages, whereas prior to April 1, 2019 licensed retailers are limited to selling 3.2% cereal malt beverages.

ORDINANCE NO. ___905____

AN ORDINANCE AMENDING THE CITY CODE TO PROVIDE FOR A CHANGE IN THE LAW REGARDING SALE OF CEREAL MALT BEVERAGES

WHEREAS, on and after April 1, 2019, Kansas State law provides that a city issued license -- for the retail sale of cereal malt beverage -- will allow the license holder to sell 6% cereal malt beverage, whereas prior to April 1, 2019, license holders are limited to selling 3.2% cereal malt beverage; and

WHEREAS, it is necessary to amend the City Code to reflect this new State law.

NOW THEREFORE, BE IT ORDAINED by the Governing Body of the City of Wellsville:

Section 1. Section 3-101 of Article 1 of Chapter III of the Wellsville Code (titled õ**Definitions**ö) is hereby amended to include a revised definition for õCereal Malt Beverageö, which shall read as follows:

(d) <u>Cereal Malt Beverage</u> means cereal malt beverage as that term is defined in K.S.A. 41-2701, and amendments thereto, and such term shall include beer containing not more than 6% alcohol by volume when such beer is sold by a retailer licensed by the City.

Section 2: <u>Repealer</u>. Any Ordinances or Code provisions inconsistent herewith are hereby repealed.

Section 3. <u>Effective Date</u>. This Ordinance shall take effect on April 1, 2019, after its adoption by the City Council, approval by the Mayor and publication in the Cityøs official newspaper.
