The regular meeting of the Wellsville City Council was held on Wednesday, November 25<sup>th</sup>, 2020 at 6:00 p.m. in the Wellsville City Hall meeting room, located at 411 Main Street. Councilmen present were Dave Rogers, Chuck Rutledge, Natalie Patton and Luke Henry. Department heads present were City Superintendent Darien Kerr, and Chief of Police John Blair.

Councilman absent was Cory Cunningham.

The pledge of allegiance and invocation were given.

Councilman Dave Rogers moved to approve the consent agenda. Councilman Luke Henry seconded. Motion passed 4-0.

The Mayor called asked for public comments. There were no public comments.

County Commissioner Don Stottlemire gave the County report.

There was a quote given for a new air conditioner at the Fire Department from A & H Heating and Air. The new unit would be \$3199.50 which includes a \$355.50 discount.

Councilman Dave Rogers moved to approved \$3739.50 for a new air conditioner from A & H Heating and Air. Councilman Luke Henry seconded. Motion passed 4-0.

City Superintendent Darien Kerr gave the public works activity report. The trees will be cut down the 17<sup>th</sup> of December. Darien said he would like to look at purchasing a skid loader in the near future. Council suggested at looking at Municipal leases from Bobcat and Cat.

Councilman Chuck Rutledge moved to approve \$5284.00 to DH Pace to replace/furnish and install 3 RSX Trolley ½ single phase w/photo eyes, 16' rail, and 2 remotes per opener.

Councilwoman Natalie Patton seconded. Motion passed 4-0.

Chief John Blair gave the police department activity report. Officer Lauren Sjorlund gave a presentation of the TransUnion TLOxp for Law Enforcement which identifies tracks and locates criminals, suspects and fugitives. The cost of this program is \$75.00 per month.

Councilman Luke Henry moved to purchase the TransUnion program for \$75.00 per month which includes 125 searches. Councilman Chuck Rutledge seconded. Motion passed 4-0.

Councilwoman Natalie Patton made a motion for City Council to recess into executive session at 6:24 p.m. to discuss performance of non-elected personnel pursuant to K.S. A. 75-4319 (b)(1). The open meeting will resume in the City Council chambers at 6:35 p.m. Councilman Dave Rogers seconded. Motion passed 4-0.

Councilwoman Natalie Patton moved to come out of executive session. Councilman Chuck Rutledge seconded. Motion passed 4-0.

No motions were made and only the above mentioned item was discussed.

Councilman Dave Rogers moved to adjourn the meeting. Councilman Luke Henry seconded. Motion passed 4-0.
