The regular meeting of the Wellsville City Council was held on Wednesday, June 30th, 2021 at 6:00 p.m. in the Wellsville City Hall meeting room, located at 411 Main Street. Councilmen present were Chuck Rutledge, Cory Cunningham, Luke Henry and Natalie Patton. Department heads present were Police Chief Danny Hackler, City Superintendent Darien Kerr and Planning and Codes official Pat Burton.

Councilman absent was Dave Rogers.

Councilman Chuck Rutledge moved to approve the consent agenda and the minutes of the previous meeting. Councilman Cory Cunningham seconded. Motion passed 4-0.

Mayor Lytle opened the meeting up for public comments. There were no public comments.

County Commissioner Don Stottlemire gave the county activity report. Don stated they have hired a new appraiser. They approved the plan for moving forward on expanding the landfill which will be a \$250,000 upgrade with more property. They reviewed the Public Works Department and the buildings. The buildings are very old and have problems with plumbing etc., they already have some monies saved for this project. There was a luncheon for all County employees and give always.

The tender agreement between North American Specialty Company and the City of Wellsville was provided for review. This agreement is for the Pine Street Sanitary Sewer replacement project that Blue Nile didn't finish and the contract amount was \$172,133.77. Councilman Chuck Rutledge moved to approve the tender agreement in the amount of \$172,133.77. Councilman Cory Cunningham seconded. Motion passed 4-0.

Natalie Patton discussed the Corn Hole tournament that was canceled and changed to July 10th.

Councilman Luke Henry moved to approve the Corn Hole tournament and Beer Garden for Wellsville Days on July 10th. Councilman Chuck Rutledge seconded. Motion passed 4-0.

Mayor Lytle talked to council regarding the City taking over the Community Building. They would still have a board and handle the rentals. The City would be responsible for maintenance and upkeep of the building. Consensus was to consider taking the community building over and talk to the Community Building board.

City Superintendent Darien Kerr gave the public works activity report. Darien updated council that chip and seal was supposed to start the week of July 9th. Liquid Engineering will be here to clean up the ground tank also.

Chief Hackler gave the Police Department activity report. Chief said he is having his Officers doing extra patrol at the park since there have been some issues with graffiti. Chief Hackler asked to be able to go to Hutchinson, for a week long leadership training if accepted the cost is \$350.00. Chief asked for PR items for the youth of the community. Chief asked for a total of \$1600.00 over a few months for items.

Councilman Luke Henry moved to authorize Chief Hackler to purchase up to \$1600.00 for PR items to purchase.

Councilwoman Patton moved to approve Chief Hackler to go to the Chief/leadership training in the amount of \$350/00

Councilman Luke Henry moved to adjourn the meeting. Councilman Cory Cunningham seconded. Motion passed 4-0.
