ORDINANCE NO. 918

AN ORDINANCE AMENDING SECTION 14-211 OF ARTICLE 2 OF CHAPTER XIV OF THE WELLSVILLE CITY CODE TO CODIFY PARKING RESTRICTIONS ON CITY STREETS

WHEREAS, the Governing Body believes it is in the best interest of the City to limit parking on certain streets within the City limits.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WELLSVILLE, KANSAS:

SECTION 1. Section 14-211 of Article 2 of Chapter XIV of the Wellsville City Code is amended to read as follows:

14-211. Parking restrictions.

(a) It is unlawful for any person, company, firm or corporation to park, cause to park, or permit to remain parked, any motor vehicle on either side of South Main Street between Fourth and Seventh Streets in the city between the hours of 1 a.m. and 6 a.m. on Tuesdays and Fridays.

(b) Angle parking at the angle indicated by markings on the curb, sidewalk, or pavement, is permitted and required on both sides of South Main Street from Fourth Street to Seventh Street.

(c) It is unlawful for any person, company, firm or corporation to park, cause to park, or permit to remain parked, any motor vehicle on either side of the following sections of streets:

- 1. Ash Street between First Street and Fourth Street.
- 2. Walnut Street between First Street and Seventh Street.
- 3. North Elm Street between Meadowbrook Lane and West First Street.
- 4. South Main Street between First Street and Fourth Street.
- 5. South Main Street between Seventh Street and the intersection of Vermont Street and Stafford Road.
- 6. North Maple Terrace between Meadowbrook Lane and East First Street.
- 7. Poplar Street within the City Limits.
- 8. West and East First Street.
- 9. West and East Fourth Street.
- 10. East Seventh Street.
- 11. East Eighth Street.
- 12. Pendleton Avenue.
- 13. East Ninth Street Terrace.

- 14. East Tenth Street.
- 15. Stafford Road within the City Limits

(d) It is unlawful for any person, company, firm or corporation to park, cause to park, or permit to remain parked, any motor vehicle on the North side of Meadowbrook Lane.

(e) It is unlawful for any person, company, firm or corporation to park, cause to park, or permit to remain parked, any motor vehicle on either side of the South side of the following streets:

- 1. Prairie Lane.
- 2. Edgewood Drive.
- 3. Downy Drive.
- 4. Cedar Lane Drive.
- 5. Benton Drive.

SECTION 2. Any ordinance or City Code provision inconsistent with new Section 14-211 is hereby repealed.

SECTION 3. This Ordinance shall take effect upon publication in the official City newspaper.
