Mayor Lytle opened the meeting up for public comments.

Paul Bean spoke about additional funds for businesses to fill gaps in funding.

County Commissioner Don Stottlemire gave the County report. Don said Dr. Bud Ransom has agreed to continue as a coroner for Franklin County with a 4 year contract. 911 was recognized for high standards recently.

The Fire District update was given.

Chris DeFazio-758 Main was present to ask for reimbursement of funds for repair on his sewer line he claims was hit by the Fiber Company and the Water Line when it was updated.

Pat Burton gave council an update and showed pictures of what happened to cause the sewer failure at that address which he believes was the Fiber Company that went thru 3 years ago.

Councilman Luke Henry stated that the Fiber Company not the City of Wellsville was negligent. The City will share the photos with the Fiber Company to help the DeFazios with possible re-imbursement.

Resolution 01-0412-2023 a Resolution for fees and rates was brought before council for approval. Councilman Chuck Rutledge asked to bump up the report costs. Councilwoman Pruitt asked to raise grave space costs along with mowing and trimming. Consensus was to make adjustments and present at the next meeting.

Chief Hackler gave the Police Department report. Chief said the move in date for the PD is Friday the 14th. Chief said he completed his Bachelors and is set to graduate the end of the month.

City Inspector Pat Burton said the trailer park will be eliminated and new structures will be going in. They had the preconstruction meeting for 6th and Willow. The developer received 1.2 million dollars and will be putting in 64 doors.
